JUDGMENT:-

Kh. Muhammad Nasim, J.- The captioned appeals by leave of the Court, have been directed against the consolidated judgment dated 12.05.2020 passed by the High Court in Writ Petitions No.2340/2016, 1025, 1040, 1048, 1063, 1084, 1098, 1107, 1061, 1062 and 1198/2017. Since, all the appeals have arisen out of the common judgment of the High Court, involving identical proposition, therefore, the same were heard together and being disposed of through this proposed judgment.

2. The facts involved in Appeal No.231/2020, briefly stated are that the appellants, Qamar Yaqoob and others, filed

different writ petitions, before the High Court, alleging therein that the Education Department advertised the posts of Primary Teachers, Junior Science Teachers and Qaris in newspapers at different dates. In response to the said advertisements, the appellants being eligible applied for appointment against the posts falling in their respective Union Councils, Constituencies of District Muzaffarabad, Kotli and Haveli, and duly participated in the test and interview. After conducting the test and interview, the merit lists were compiled, wherein, the appellants, attained top merits positions, hence on the recommendations of the respective Selection Committees their appointments were made vide orders bearing No.3490-91, dated 23.05.2016, 3508-9 dated 23.05.2016, 3488-89 dated 23.05.2016, 3484-85 dated 23.05.2016, 3494-95 dated 23.05.2016, 3567-68 dated 23.05.2016, 40-42/2016 dated 02.01.2016, 31-33/2016 dated 02.01.2016, 64-66/2016 dated 02.01.2016, 37-39/2016 dated 02.01.2016, 20-22/2016 dated 02.01.2016, 22-24/2016 dated 02.01.2016, 2521-22/2016 dated 29.03.2016, 28-30/2016 dated 02.01.2016, 1180-82 dated 03.03.2016, 2735-37/2016 dated 22.04.2016, 2774-76 dated 23.04.2016, 2732-34 dated 22.04.2016, 1594-96 dated 26.03.2016, 25-27 dated 02.01.2016, 61-63 dated 02.01.2016, 68-73 dated 07.04.2016, 80-85 dated 07.04.2016, 74-79 dated 07.04.2016 188-93 dated 06.05.2016, 6104-05 dated 30.12.2015, 86-91 dated

In compliance of the aforesaid orders, the appellants submitted their joining reports before the concerned authorities which were allowed. It was further alleged that the appellants are performing their duties with full devotion, dedication and to the entire satisfaction of high-ups. It was further averred that the official respondents have issued a letter/script dated 31.05.2017, whereby they intend to cancel all the appointments made after the issuance of Notification dated 26.11.2015, which is illegal and against the rights of the appellants, hence they constrained to file the writ petitions for protection of their appointment orders and for quashment of the letter/script dated 31.05.2017.

3. The facts forming the background of Appeal No.232/2020, are that the appellants, Nagina Kousar and others filed writ petitions before the High Court, alleging therein, that they were appointed as Primary Teachers on adhoc/temporary basis in different schools of District Kotli, against the vacant/available posts, subject to condition of qualifying the test and interview. Later on, the official respondents advertised the posts occupied by the appellants in "*Daily Kashmir News Kotli*, vide different advertisements. In response to the said advertisements the appellants applied for their appointments against their respective Union Councils and participated in the test and interview. After conducting the test and interview, Union Council wise merit lists were prepared on 26.08.2015, 15.12.2015, 15.03.2016, 12.04.2016, 20.04.2016, 21.04.2016 and 26.05.2016, wherein, the appellants stood on top, hence in pursuance of the aforesaid merit lists, the appointments of the appellants on permanent basis, were made on the recommendations of the respective Selection Committees vide orders bearing No.151-52, dated 08.01.2016, 149-50 dated 08.01.2016, 509-09 dated 27.01.2016, 3246-49 dated 25.03.2016, 3230-33 dated 25.03.2016, 3254-57 dated 25.03.2016, 140-45 dated 07.04.2016, 135-39 dated 07.04.2016, 122-27 dated 07.04.2016, 116-21 dated 07.04.2016, 152-57 dated 07.04.2016, 4586-88 dated 15.04.2016, 3548-50

dated 23.05.2016, 3544-45 dated 23.05.2016, 3541-42 dated 23.05.2016, 3555-56 dated 23.05.2016, 3537-38 dated 23.05.2016, 3553-54 dated 23.05.2016, 3530-31 dated 23.05.2016, 3482-83 dated 23.05.2016, 3518-19 dated 23.05.2016, 3551-52 dated 23.05.2016 and 6082-83 dated 30.12.2015, respectively. After issuance of the aforesaid appointment orders the appellants joined their respective positions. It was alleged that the official respondents have issued the letter dated 31.05.2017, whereby they intend to cancel all the appointments made after the issuance of the notification dated 26.11.2015, which is illegal and against the principle of natural justice. They prayed for protection of their appointment orders and quashment of the above-mentioned letter.

4. The facts forming the background of Appeal No.234/2020, are that the appellants, Rizwana Azad and others filed writ petitions before the High Court, alleging therein, that they were appointed as Primary Teachers in different schools of District Kotli, after due process of selection i.e. advertisement of the posts, conducting test and interview and on the recommendations of the respective Selection Committees vide orders bearing No.6094-95 dated 30.12.2015, 6092-93 dated 30.12.2015, 20-25 dated 04.01.2016, 2856-60 dated 19.03.2016, 2871-75 dated 19.03.2016, 2725-28 dated 15.04.2016, 2725-28 dated 15.04.2016, 4717-20 dated 15.04.2016, 4600-4603 dated

15.04.2016, 5586-88 dated 03.05.2016, 5586-88 dated 03.05.2016, 5615-17 dated 12.05.2016, 5812-14 dated 12.05.2016, 5815-17 dated 12.05.2016, 3496-97 dated 23.05.2016, 4184-86 dated 30.06.2016 and 6862-64 dated 03.06.2016, respectively. It was alleged that after issuance of the aforesaid appointment orders, the appellants joined their respective positions. The official respondents are bent upon to cancel their appointment orders in pursuance of the Notification dated 26.11.2015 and letter dated 31.05.2017, which is against law. They prayed for protection of their appointment orders and quashment of the letter dated 31.05.2017.

5. The brief facts forming the background of Appeal No.235/2020, are that the appellant, Sidra Kanwal along with proforma-respondents, filed writ petition No.1061/2017, before the High Court, alleging therein that the Elementary and Secondary Education Department published an advertisement dated 17.06.2015, through which the posts of Junior General line and Junior Science Teacher pertaining to Constituency No.1, Muzaffarabad, were advertised. The appellant Sidra Kanwal applied against the post of Junior Science Teacher and participated in the test and interview. After conducting the test and interview a merit list was compiled on 28.12.2015, wherein, she attained top merit position, consequently, on the recommendations of the

respective Selection Committee her appointment order was issued on 28.12.2015. The official respondents in the garb of notification 26.11.2015 and letter dated 31.05.2017, want to cancel the appointment order, hence she was constrained to file the writ petition.

6. The facts of Appeal No.236/2020, in brief, are that the appellants, Muhammad Yaseen and others, filed writ petition No.1062/2017, before the High Court, alleging therein that they were appointed as Primary Teachers in different schools of District Kotli. The posts held by the appellants were duly advertised and after conducting the test and interview the merit lists were compiled wherein the appellants attained top merit positions in their respective Union Councils, resultantly, on the recommendations of respective Selection Committees the appointment orders of the appellants bearing No.1047-50 dated 02.02.2016, 1055-58 dated 02.02.2016, 1059-62 dated 02.02.2016, 1063-66 dated 02.02.2016, 1031-34 dated 02.02.2016, 1035-38 dated 02.02.2016, 1043-46 dated 02.02.2016, 1039-42 dated 02.02.2016, 2605-09 dated 10.03.2016, 6534-38 dated 31.05.2016, 4362-64 dated 14.04.2016, 6086-87 dated 30.12.2015, 156-59 dated 08.01.2016, 3258-61 dated 25.03.2016 and 236-40 dated 02.06.2016, respectively, were issued. It was alleged that the official respondents in the guise of notifications dated 26.11.2015,

18.07.2016 and letter dated 31.05.2017, intend to cancel their appointment orders, which is against the rights of the appellants. They sought annulment of the aforesaid notifications/letter.

7. The brief facts of Appeal No.237/2020, are that the appellants, Abdul Khaliq and others, filed writ petition No.1061/2017, before the High Court, alleging therein that the Education Department advertised in different newspapers on different dates, the posts of Primary Teachers, pertaining to the union councils of District Muzaffarabad. In pursuance of the advertisements the appellants applied and participated in the test and interview. After conducting the test and interview merit lists were prepared, wherein, the appellants attained the top positions, hence on the recommendations of the respective Selection Committees their appointments as Primary Teachers were made vide orders bearing No.43-45 dated 02.01.2016, 46-48 dated 02.01.2016, 55-57 dated 02.01.2016, 2497-99 dated 28.03.2016, 2068-70 dated 03.03.2016, 3491-93 dated 28.04.2016, 3488-90 dated 28.04.2016, 49-51 dated 02.01.2016, 2895-97 dated 05.05.2016, 3377-79 dated 18.01.2016, 3684-86 dated 14.05.2016, 2380-82 dated 21.03.2016 and 2320-22 dated 12.04.2016, respectively. It was alleged that the official respondents in the garb of notification 26.11.2015 and letter dated 31.05.2017, want to

cancel their appointment orders, hence they constrained to file the writ petition.

8. The brief facts of Appeal No.238/2020, are that the appellant, Saima Rasheed and others, filed writ petition No.1084/2017, before the High Court, alleging therein that they were appointed as Primary Teachers on adhoc basis. The posts occupied by the appellants were duly advertised and the appellants applied for the same and participated in the test and interview conducted by the concerned Selection Committee. Thereafter, the merit lists were prepared wherein the appellants attained top merit positions, hence on the recommendations of the respective Selection Committees their appointment orders on permanent basis were issued vide orders bearing No. 6080-81 dated 30.12.2015, 3410-12 dated 26.03.2016, 4593-96 dated 15.04.2016, 4597-99 dated 15.04.2016, 4589-92 dated 15.04.2016, 5964-67 dated 17.05.2016, 3512-22 dated 23.05.2016, 3510-11 dated 23.05.2016 and 3496-97 dated 23.05.2016, respectively. It was alleged that the official respondents have issued the letter dated 31.05.2017, whereby they intend to cancel their appointment orders, which is against the fundamental rights of the appellants, hence they are constrained to file the writ petition.

09. The facts involved in Appeal No.04/2021, in brief, are that the appellant, Maria Javed along with others, filed writ petition

No.1063/2017, before the High Court, alleging therein she was appointed as Primary Teacher vide order bearing No.2729-31 dated 22.04.2016. The post held by the appellant was duly advertised. She applied for the same and participated in the test and interview. The appellant attained top position in the merit list prepared by the Selection Committee, consequently, her appointment order was issued on the recommendations of the Selection Committee. It was alleged that the official respondents want to cancel her appointment order in the light of the script/letter dated 31.05.2017, which is against the fundamental rights of the appellant, hence, she constrained to file the writ petition.

10. The brief facts of Appeal No.92/2021, are that the appellants, Muhammad Safeer and others, filed a writ petition before the High Court, alleging therein they were appointed as Primary Teachers after advertisement of the posts and conducting the test and interview. The appointments of the appellants, were made on the recommendations of the respective Selection Committees, vide orders bearing No.2519-20 dated 29.3.2016, 2065-67 dated 03.03.2016 and 2937-39 dated 08.05.2016. After the issuance of their appointment orders the appellants joined their respective places of posting. It was alleged that the official respondents in the garb of notification 26.11.2015 and letter dated 31.05.2017, want to cancel their appointment orders, which is

against the fundamental rights of the appellants, hence they constrained to file the writ petition.

All the aforesaid writ petitions were contested by the official respondents, herein, by filing the written statements, wherein, it was alleged that the learned High Court in the case titled "*Traj Imtiaz vs. DEO & others*" dated 10.05.2016, held that after the issuance of notification dated 26.11.2015, the appointments against the posts of non-gazetted teaching staff are not sustainable and issued the direction to the Education Department to fill up the posts in the light of the notification dated 26.11.2015. Similarly, the Apex Court in its judgment delivered in the case titled "*Asia Tabassum vs. Salma Manzoor and others*", (Civil Appeal No.142/2016, decided on 17.06.2016), held that in condition No.III of the notification dated 26.11.2015, a clear mode of appointment against the non-gazetted posts has been provided through NTS, which is neither un-constitutional nor in violation of any law. In this state of affairs, the letter/script dated 31.05.2017 has been issued in compliance of the judgments of the High Court as well as the Apex Court. As the appointments of the appellants, herein, were made after the issuance of the notification dated 26.11.2015, hence in view of the aforesaid judgments, the appointments of the appellants, are illegal and liable to be cancelled. After necessary proceedings, the learned High Court

through the impugned judgment dismissed all the writ petitions, hence the captioned appeals by leave of the Court.

11. Mr. Abdul Rasheed Abbasi, the learned Advocate representing the appellants, in Appeals No.232 and 237 of 2020, argued the case at some length and submitted that the impugned judgment passed by the learned High Court is against law and the record of the case, which is not sustainable in the eye of law. He submitted that the posts against which the appellants were appointed, fell vacant much earlier to the issuance of Notification dated 26.11.2015. The process of selection against the said posts was also commenced prior to the issuance of the notification dated 26.11.2015 and the appointments of the appellants, were made on the recommendations of the respective Selection Committees, hence the services of the appellants cannot be terminated in the garb of notification dated 26.11.2015, on the ground that their appointments have not been made through NTS. He further argued that the notification dated 26.11.2015, has been issued for 1037 posts which have been created in the Education Package, whereas the posts held by the appellants are not included in the said package. Furthermore, no retrospective effect has been given to the notification dated 26.11.2015, hence the same is not applicable to the posts occupied by the appellants. The learned Advocate further submitted that the proposition involved in the matter has already

been resolved by this Court in the case reported as *Syed Adnan Ejaz Gillani & others vs. District Education Officer and others* [2018 SCR 245], wherein, it has been categorically held by this Court that NTS policy is applicable only to those appointments against the posts for which the process of selection commenced after the notification dated 18.07.2016. The aforesaid judgment was referred to and relied upon by the appellants, at the time of arguments before the High Court, but the learned High Court failed to consider the same and illegally dismissed the writ petitions while misinterpreting the judgments titled “*Asia Tabassum and others vs. Salma Manzoor and others*”. The learned Advocate, further argued that the appointments of the appellants have been made after due process of law on the recommendations of the respective Selection Committees and valuable rights have been accrued in their favour, which cannot be snatched in the garb of notification dated 26.11.2015 and letter dated 31.05.2017. The impugned judgment has been passed contrary to the judgment of this Court reported as *Syed Adnan Ejaz Gillani & others vs. District Education Officer and others* [2018 SCR 245]. In support of his version, the learned Advocate, also referred to and relied upon the case reported as [PLJ 1999 SC (AJ&K) 334] and prayed for acceptance of appeals.

12. M/s. Kh. Attaullah Chak, Barrister Humayun Nawaz Khan, Sardar M.R. Khan, Mansoor Pervaiz Khan, Sh. Muhammad Saleem and Amjad Hameed Siddiqui, the learned Advocates, representing the appellants in their respective appeals, adopted the arguments advanced by Mr. Abdul Rashid Abbasi, and prayed for acceptance of their appeals, however, Mr. Amjad Hameed Siddiqui, pointed out that the appellant Sidra Kanwal, has been appointed as Senior Science Teacher (B-16) on the recommendations of the Public Service Commission, vide notification dated 20.01.2020.

13. Conversely, Kh. Muhammad Maqbool War, the learned Advocate-General and Mr. Sajid Hussain Abbasi, the learned Advocate, while appearing on behalf of the official respondents, forcefully opposed the arguments advanced on behalf of the appellants and submitted that the impugned judgment is legal and perfect in all aspects, calling for no interference by this Court. They submitted that according to the notification dated 26.11.2015, non-gazetted posts have to be filled in through NTS. The letter dated 31.05.2017, has been issued in the light of the judgment of the High Court delivered in the case titled *Iraj Imtiaz vs. District Education Officer & others*. They further stated that writ jurisdiction cannot be exercised for retention of ill-gotten gains. The appellants have made vague assertions in their writ

petitions and failed to bring on record any supportive document, thus, the writ petitions have rightly been dismissed. They contended that admittedly the appointments of the appellants have been made after the issuance of the notification dated 26.11.2015, without NTS, hence the same are liable to be cancelled and prayed for dismissal of the appeals.

14. We have considered the arguments advanced by the learned Advocates, representing the parties and gone through the record made available along with the impugned judgment. The perusal of the record shows that the Education Department advertised the posts of Primary Teachers, Junior Science Teachers and Qaris, pertaining to different Union Councils and Constituencies of District Muzaffarabad, Kotli and Haveli and in pursuance of the said advertisements the test and interview were conducted. After conducting the test and interview the merit lists were compiled and the appointment orders of the appellants herein, were made on the recommendations of the respective Selection Committees. In compliance of the appointment orders, the appellants joined their places of posting. On 31.05.2017, the Secretary Elementary and Secondary Education issued a script/letter, whereby the detail of all the appointments of non-gazetted teaching staff made after the issuance of notification dated 26.11.2015, were sought. Feeling aggrieved, the appellants

filed several writ petitions in the High Court for protection of their appointment orders and quashment of the abovementioned letter/script. After necessary proceedings, the learned High Court through the impugned consolidated judgment dismissed all the writ petitions in the following terms:-

“In view of the above, the writ petitions No.1025/2017, 1040/2017, 1048/2017, 1063/2017, 1084/2017, 1098/2017, 1107/2017, 1061/2017, 1062/2017, and 1198/2017 are hereby dismissed with the observation that all the appointments of the petitioners are illegal and letter dated 31.05.2017 has rightly been issued in light of judgment of apex Court. Writ petition No.2340/2016 is hereby also dismissed being no substance...”

15. It may be observed here that the Government of Azad Jammu and Kashmir issued the Notification dated 26.11.2015, through which 1037 posts of different cadets in the Education Department were created and the mode for filling up the said posts in three phases was provided. In condition No.iii of the Notification dated 26.11.2015, it was provided that against the newly created 1037 posts no appointment shall be made on adhoc, temporary or subject to the recommendations of the Selection Committee, rather the gazetted posts shall be filled in through Public Service Commission, whereas the non-gazetted posts shall be filled in through National Testing Service (NTS). For convenience the condition No.III of the notification dated 26.11.2015, is reproduced here which reads as under:-

"(iii) نو تخلیق شدہ 1037 اسامیوں پر ایڈہاک، عارضی یا تابع توثیق سلیکشن کمیٹی تقرریاں عمل میں نہیں لائی جائیں گی بلکہ جریدہ اسامیوں کو بذریعہ پبلک سروس کمیشن جبکہ غیر جریدہ تدریسی اسامیاں بذریعہ NTS پر کی جائیں گی۔"

16. The version of the appellants, herein, is that the posts held by them are not included in the package of 1037 posts mentioned in the notification dated 26.11.2015, rather the same were already available prior to the issuance of the notification dated 26.11.2015, hence the notification dated 26.11.2015, is not applicable to the case of the appellants. In this regard, we have perused the grounds of writ petitions. In ground "B" of the writ petitions the appellants have categorically stated that the posts held by the appellants were not included in the package mentioned in the notification dated 26.11.2015. The respondents in their written statements filed before the High Court, have not specifically denied ground "B" of the writ petitions. According to the settled principle of law, governing the pleadings, every question of fact must be denied specifically or by necessary implication and evasive denial amounts to admission. It was enjoined upon the official respondents to rebut the version of the appellants specifically, which is lacking in the case in hand. Meaning thereby, that the posts in question were available prior to the issuance of the notification dated 26.11.2015. We are fortified in our view from

the case reported as *Shahida Khadim vs. Secretary Education & 5 others* [2002 SCR 315], wherein it was observed as under:-

“7. We have given our due consideration to the arguments advanced at the Bar and perused the relevant record. It may be stated that so far as the merit of the appellant is concerned, that has not been repudiated by any of the respondents. Respondent No.3 has evasively denied the allegation made in para No.2 of the writ petition filed by the appellant. It remains now settled that an evasive denial under Order VIII, rule 5 of the Code of Civil Procedure shall be deemed to be the admission of the averment made in the relevant para. So the averment made in para No.2 of the writ petition that the appellant stood first in the merit list stands admitted by the respondents.”

Similarly, in the case reported as *Afaq ul Islam Qureshi vs. Azad Govt. & 4 others* [2019 SCR 926], it was observed as under:-

“A perusal of the above would show that the Public Service Commission in its reply has observed that explanation has been given in the preceding paragraphs. A perusal of those paragraph reveals that the question of qualifying the test and interview has not been mentioned at all. Similarly, the reply of the Government, who was supposed to give figures and deny the allegation while giving break-up of the posts, was also of evasive nature. By now, law is well settled that if a fact is pleaded and is not denied by the other side specifically and reply is evasive in nature, then the same can be treated as admission on the part of the respondents.”

17. We have also considered the argument of the learned Advocate-General that the script/letter dated 31.05.2017, has been issued in compliance of the judgment of the High Court delivered in the case titled “*Iraj Imtiaz vs. DEO and others*” and the judgment of this Court delivered in the case titled “*Asia Tabassum*

vs. Salma Manzoor and others". In the referred judgments the learned High Court as well as this Court observed that after the issuance of the notification dated 26.11.2015, the posts of non-gazetted teaching staff shall be filled in through NTS, whereas in the instant case, the situation is quite otherwise, as the posts held by the appellants were available prior to the issuance of the notification dated 26.11.2015, and the process of selection was also commenced prior to the issuance of said notification. In this state of affairs, we do not agree with the argument of the learned Advocate-General that after the issuance of notification dated 26.11.2015, no appointment could be made without NTS because when the posts in question were advertised and selection process was made the notification dated 26.11.2015 was not holding the field. In this regard Mr. Abdul Rashid Abbasi, the learned Advocate, representing the appellants, has rightly referred to and relied upon the reported judgment titled *Syed Adnan Ejaz Gillani & others vs. District Education Officer and others* [2018 SCR 245], wherein, it was observed as under:-

The learned counsel for the appellants, *Education Department & others*, submitted that as through notification dated 18.07.2016, the policy has been changed and now the selection is made through NTS, therefore, on the strength of previous advertisement/policy the selection process cannot be made. We do not agree with this argument as when the disputed posts were advertised and selection process was made the said notification was not in field,

therefore, it cannot be said that the previous selection process was contrary to the new NTS policy notification dated 18.06.2016.

8. Keeping in view the controversy involved in the instant appeals, the Education Department is directed to initiate the selection process for both Male/Female Primary Teachers without inviting fresh applications according to the previous rules/policy prevailing at that time and complete the same within a period of three months positively.”

18. There is another important aspect of the matter that the posts in question were duly advertised. The appellants being eligible applied and participated in the test and interview and thereafter the competent authorities issued the appointment orders under the recommendations of the respective Selection Committees. The appellants are performing their duties since their dates of appointment and nobody has challenged the same at any proper forum, hence a valuable right has been accrued in favour of the appellants, which cannot be snatched in the garb of notification dated 26.11.2015 and letter/script dated 31.05.2017. Reliance may be placed upon a case reported as *Muhammad Imtiaz Khan vs. Azad Government and 3 others* [PLJ 1999 SC (AJK) 142], wherein it was observed as under:-

“The principle of law laid down above is fully applicable to the present case. The Public Service Commission had commenced the selection process by advertising the disputed post and the appellant had duly applied for it. It is nobody’s case that the requisition was withdrawn by the Government. Thus a right had come to reside in the appellant that he should

be considered for appointment to the advertised post in the light of the rules prevalent at the time when the post was advertised. Thus, the view taken by the High Court is not correct.”

In another case reported as *Nasreen Akhtar and 3 others vs. Sameena Bilqees and 3 others* [2006 SCR 312], it was observed as under:-

“14. So far as the appellants Nasreen Akhtar and others are concerned, it is an admitted fact that they appeared in the light of advertisement dated 25.7.2004 before the Selection Committee and passed the test and interview. Under law they are entitled to be appointed against the vacant posts for which they contested. Even otherwise they were not party before the High Court and the judgment under challenge has been passed at their back. The Education Department should have issued their appointment orders in the light of merit list but unfortunately they were dragged in the litigation which is the fault on the part of officials of Education Department.”

19. Since, the appellant i.e. Sidra Kanwal in Appeal No.235/2020 has been appointed as Senior Science Teacher (B-16) on the recommendations of Public Service Commission vide notification dated 20.1.2020, hence, her appeal has become infructuous.

In view of the above stated reasons, appeal No.235/2020, is dismissed as having become infructuous, whereas while accepting the appeals bearing No.231, 232, 234, 236, 237, 238 of 2020, 04 and 92 of 2021, the impugned judgment passed by the learned High Court dated 12.05.2020, is hereby set aside.

Consequently, the script/letter dated 31.05.2017, is hereby quashed to the extent of appellants, herein. No order as to costs.
